Apprenticeship is a proven system of education and hands on training. Your community college district participates in an apprenticeship program. Current apprenticeship faculty and the California Apprenticeship Council have raised concerns about getting the best-qualified instructors into the apprenticeship classrooms, and efforts are underway to review and revise the minimum qualifications for apprenticeship faculty.

Out of concern regarding feedback from their own apprenticeship faculty, the Foothill and De Anza colleges Academic Senates passed resolutions urging the ASCCC to rely upon the apprenticeship faculty discipline experts as they consider appropriate minimum qualifications for apprenticeship instructors.
