New Full-time Faculty: Katie asked the senate to review the ASCCC material related to the Title 5 "2nd minimum qualification for hiring faculty and academic administrators" which requires a demonstration of "sensitivity to and an understanding of the diverse academic, socioeconomic, cultural, ability, and ethnic backgrounds of our community college students."
