#### **Discussion and action: Setting goals for Academic Year 2022-23**

Gabriela says we had about 25 goals from the previous senate of which she reviewed with the council. From the faculty feedback she received for the 22-23 goals, she went through all the points and condensed them into issues that the ASC can influence and went over them with the ASC.

A suggestion was to remove the Equity Rubric because it's already in eLumen as part of the Content Review form.

Gabriela will continue to work on this to remove what has already been finished and bring it back for more discussion.

#### **Instructional faculty and Counseling faculty collaboration – Issues for mutual support and improvement**

What Counseling would like faculty to understand about Counseling. (Lorena, Jared)

- That Counseling are faculty
- They have department hours
- 14 fulltime counselors but are in other programs such as EOPS, DSWS Wellness/Mental Health, CTE, Puente, Veterans, Transfer, etc.
- Just not enough availability to see students
- Appointments – seeing students in person, video, phone, by appointments, drop-ins, which take 30-60 minutes for each visit
- Counselors are faculty and shouldn't have to work summers or winter breaks but those are peak times for student meetings
- Counseling supports over 22 programs campus-wide and Community efforts
- Counseling Faculty retirements are not replaced

- Counseling Box 2A not approved
- Counseling Faculty committee appointments
- Lack of VPSS stability
- Non-existent collaboration between Outreach, Welcome Center and Counseling
- 1,742 students seen in August
- Solution may be to add additional Counseling hours during peak times of day/semester, etc.
