**NEW BUSINESS:** 

**Improving Connection Between CCC, LMC and DVC Faculty Regarding Hiring Pools, etc.** The relationship between the three campuses' departments was discussed. Do they have the same department goals? The ASC feels that this standard is stating that faculty will be evaluated on whether they have reached the goals on their SLO. A CAG (Classroom Assessment Group) workshop on techniques for assessing was given a few years ago. This workshop that would benefit all faculty. Fritz will find the name of the book used in the workshop. It appears that even though SLO were not suppose to be evaluated, it's starting to slip into evaluation. SLO are projected target areas which students are expected to achieve, not used to evaluate faculty. The Academic Senate needs to create a process to request SLO to be libraried in the Senate office. **Shared Governance Committees** DGC is the district-wide shared governance council that discusses issues that will be taken to the Board. A subcommittee has been formed and is charged with developing a process to evaluate shared governance council. The ASC was asked how to survey committees as to what is the purpose of each committee; what are the goals and objectives, and, whether the goals were reached. The ASC felt these issues could possibly be achieved with interviews or entry/exit surveys. The ASC was concerned with who really runs these shared governance committees.
