❖ Information / Discussion: (Each discussion Item will be 10 minutes after the third Item will be lowered to 5 minutes)

- Chancellor Wood
 - ◆ Chancellor Wood had a family emergency. He was unable to attend the ASU meeting we will work together to schedule another meeting time for him to discuss the hiring process of both the CCC president and The Chancellor's position.
- Sustainability
 - ◆ Bruce King Buildings and Grounds Manager along with Luci Castruita
 - ◆ , a counselor, came to the board and proposed implementing new drinking fountains in the SAB and the AA buildings.
 - ◆ One new water fountain cost roughly 5,000 dollars to implement, the sustainability committee is willing to put in the total amount of money that ASU will contribute to the implementation of the water fountain.
 - ◆ They plan on adding one water fountain in both upstairs and downstairs AA along with one in the downstairs part of the SAB.
 - ◆ Already fountains have been implemented in both the Library and the SSC.

The ASU board will get back to them with the total amount of money that the ASU is willing to contribute in 2 weeks.

- ASU Secretary
 - ◆ The ASU secretary has not been able to accurately do the minutes this has been happening for some time and should not be the case.
 - ◆ We need the minutes to be accurate especially since soon the minutes will be posted online when the website is up. Since this is an issue that seems to continue the discussion of removing the current Secretary has been taken to account.

Alfredo called a Vote of no Confidence:

(Taken from Article X Discipline and Expulsion of Members, Section 10.1 Sub-Section B)

- 1) Any three (3) ASU Board members acting together may call for a Vote of No-Confidence at any time for the removal of an ASU Executive.

- 2) Any ASU Executive shall serve until a two-thirds (2/3) majority of the ASU Board delivers a Vote of No-Confidence, at which time said ASU Executive shall step down from office and assume the position of ASU Senator.

The vote of No confidence was not fully completed this will be discussed once again at the next ASU meeting.
