- A. Maritez Apigo -Maritez presented on OER Open Educational Resources and ZTC Zero Textbook Costs initiatives; these efforts are to remove the barrier of cost and accessibility to class materials for students. Total of student costs saved by current OER/ZTC implementations: \$74,581. To expand outreach and allow students to be knowledgeable of what OER/ZTC resources are and which classes have implemented these resources, OER/ZTC committees have curated an accessible list of OER/ZTC courses offered at Contra Costa College that will be published on an online page to further support and increase accessibility for students at CCC. Carlos Solano, Erica Padilla, Kevin G. Ruano Hernandez, Claudio Lopez, and Meaghan Yarnold will provide testimonials for the web page on how ZTC and OER resources have helped throughout their academic careers. Maritez suggests implementing the disclosure of Textbook costs on class syllabuses/descriptions, so that students may be pre-informed and prepared for the extra material cost of classes; ASU President will be discussing this initiative with the District Chancellor.
- B. Thanksgiving Food Drive- The board will conduct a canned food donation center, and with the materials donated propel a weekly canned food drive throughout the month of November 2021. Meaghan Yarnold and Claudio Lopez will support Carlos Solano with managing donations and food drive events. Kevin G. Ruano Hernandez will be conducting outreach for the event.
