NEW BUSINESS

LDTP (**Lower Degree Transfer Pattern**) Kenyetta Tribble explained that the CSU does not have course outlines, only common course numbering call TCSU, which is like the CAN system. CAN is good only until Fall 2009. **TCSU** are individual CSU transfer course numbers that are assigned to identify lower-division coursework students may take at CCC to prepare for high demand majors at the CSU (in which at least 80% of the course must contain the CSU course.) Proposed Liberal Arts Degree Donna Floyd and Kenyetta Tribble presented the new Liberal Arts Degree requirements that will be listed in the 2008-09 catalog. An area of concentration is required for the Liberal Arts Degree. The State Chancellor's Office has given their approval and the CCC Liberal Studies Degree will be grandfathered in. This will be brought back as an action item on the next CIC agenda.

CIC Manual Revision The manual is being revised and the CIC will be kept abreast of the revisions by email attachments. The members are asked to review the attachments and inform the CIC office of any concerns or suggestions. A section will be added to the course proposal and outline indicating whether a course has been cross listed with another. A justification statement section will be added to the new course proposal explaining the need for offering students the course and a section for the Departmental Goals Justification Statement and how the course is consistent with strategic planning goals for each Department. Also, the Cultural Pluralism Statement (required for CSU GE transferable courses only) will be added to the proposal form thus reducing the possibility of failing to attach these required statements to the new course proposal and having them readily available for Content Review.

CIC ANNOUNCEMENTS and OPEN DISCUSSION An SLO will be required with any CIC course action item proposal effective immediately. It is also noted that the effective date on all CIC proposals will be 2008-09 catalog until further notice.

The complaint is that if a major has not been approved, it should not be listed on the college website. Apparently the student took the required courses for the major only to find out when he applied for graduation or for the Certificate of Achievement, that it was not an approved major.
