Clarifying Catalog Language for Optional Courses (List A, B, C) for Transfer Degrees The language on the TMC template, in regards to lists such as A, B, C, etc., is confusing when its listed in the catalog. The TMC templates can't be changed so the language in the catalog must be written clearer since A&R goes by what is in the catalog. The language used in the English AAT to explain the lists is well written and should be used as an example for other ADT programs. Tish suggested having a group assigned to create standard language for those degrees.

**New Distance Education Form** When CurricUNET began, the DE Supplement section was not Title V compliant so we had to attach a hard copy of the form. The form has been revised and brought up to compliance. This is a first read for the form and it will be returned to the next agenda for approval with the word "CurricUNET" being corrected throughout, and the third checkbox choice on the second page, "New course to be offered exclusively in a distance learning mode." removed. It will then be uploaded and used in CurricUNET.
