PSYCH-222 Culture and Ethnicity in Social Psychology

Non-Substantial Change: Content review. Updated outcomes, methods of evaluation and instruction, assignments, lecture content, textbook. DE form updated to latest version. Title changed to Multicultural Psychology.

PSYCH-132 Introduction to Abnormal Psychology

Non-Substantial Change: Content review. Updated objectives, outcomes, methods of evaluation and instruction, assignments, lecture content, textbook. Distance Education form updated to latest version.

ACTION: Katie motioned to approve; Robert seconded; Mark, Robert, Laura, and Katie were all in favor; no abstentions.

CULIN-127 Becoming ServSafe Certified

Non-Substantial Change: Content review. Updating course description.

ACTION: Katie motioned to table to next consent agenda pending corrections to assignments, evaluation, and transfer clarity; Laura seconded; Mark, Robert, Laura, and Katie were all in favor; no abstentions.

CULIN-130 Introduction to Commercial Baking

Non-Substantial Changes: Content Review. Update out of class assignments, lab content, textbook. Hours changed from 54 lec/360 lab to 36 lecture/378 lab with no change in unit value. (*This course was tabled from the 9/10/18 and 9/24/18 agendas, due to non-representation*)

HIST-120 History of the United States (Colonial - 1865)

Non-Substantial Changes: Content Review. Update objectives, textbook

ACTION: This course was tabled due to non-representation.

DISCUSSION ITEMS

As part of the content review process for courses taught online, CIC should verify that the Distance Education supplement on file is the most recent version available, to maintain Title 5 compliance. The DE committee discussed this last month and was in support of updating to the new form because the new form contains a new Title 5 requirement for DE courses (student-to-student contact) that the old form does not include.

New SLO checkbox in CurriQunet CurricUNET has made changes to the program during the summer that were not communicated well, and not agreed upon, thus the new SLO checkbox in the Course Outcome section. It was meant to create a better flow of choice selection when assessing the SLO in the SLOA module. Katie asked that when changes are made to CurricUNET, they are noted in the CIC minutes.

Understanding Content Review Title V requires all courses to go through Content Review every six years which is the process where the department has reviewed the requisites to establish that each is still supported by its faculty; that the students would not benefit from additional requisites to the course; and that the department has reviewed the current course outline and finds it satisfactory.

It was motioned by Katie and seconded by Robert that the Technical Committee create a proposal of mandated scheduled meetings for each department for courses that are past due for content review starting in December.
