This was a discussion item on 4/26/21. It was proposed to add an optional field under "Other Instructional Materials" in eLumen course outlines. Help text for the field includes the following: *Must be stable and publicly available as published textbooks dated within seven years for approval. All of the following needs to be included: Author (last name first). Title. Edition or Version (if beyond 1st). Publisher, Publication Year, or Revision date. ISBN, URL. License. EXAMPLE: Dillon, Dave. Blueprint for Success in College and Career. Version 1.3. Rebus Community, 2018. ISBN 9781989014042, press.rebus.community/blueprint2/. Licensed under CC BY 4.0.* 

Najia said that using OER will not affect GE articulation as long as the OER meets traditional textbook requirements for GEs. However, it may affect course articulation to individual universities. There are no clear statements regarding course-to-course articulation with each university campus department because each campus department chair will determine to approve community college courses for their own department.
