#### **Emergency Proposal Guidelines** Tabled for lack of time.

CCC GE Area Approval Process (tabled 9/27/21 due to lack of time) DVC uses all approved IGETC courses for their local GE requirements, but would might be a little harsh to do that for students who are only going after a local AA degree. LMC has a separate committee who reviews courses for GE and then brings it to CIC for approval. There was a suggestion to note on the agenda that the GE course is under review and if it is under your area, if you have any concerns or input, please contact your CIC representative. There was a suggestion to use the Title 5 criteria for GE language to review courses requested for GE, or using Title 5, come up with our own list. Najia will ask LMC's GE Committee what criteria they use. Najia noticed that Title 5 is very general whereas the CSU is more specific. Any course that is CSU/IGETC/UC approved automatically becomes local GE. We could go by CSU/IGETC areas guidelines. If a course doesn't get approved, we can give them the CSU guidelines to revise the course. The committee agreed that the decision is made, using these tools (Title 5 and CSU Guidelines) along with the departments' desires, when it comes to CIC. Articulation doesn't decide GE areas. Anthony will share the proposed process with the Academic Senate. This will also be added to the CIC Handbook.
