Since Ethnic Studies is a newer GE requirement, we want to make sure we are meeting student demand/need. The committee concluded that we have three Area F approved Ethnic Studies courses which are offered often enough to meet student demand and give students choices. Therefore, any new Ethnic Studies courses will go through the regular CIC queue and do not count as an emergency.
