The attendee's examples ranged from shifting educational focus based on a survey resulting in future job opportunities, trends in bloodwork, to SAT scores and college opportunities.</li> <li>Brad Phillips shared the focus for meeting along with the IEBC model: <ul> <li>discover what is meant by culture change – change behavior which changes culture</li> <li>understand principles and practices of good data use – making correct judgements about the data</li> <li>gain insight about what data our college should focus on</li> </ul> </li> </ul>
