1. Reports - Classified,	Mercy reported the Classified Senate met yesterday. They have monies

	Tahoe.
	Terence reported they are looking at the Web Curriculum System they
	use at DVC. We call it the Curriculum Management System and will
	begin using it at the CIC meetings so everything will become paperless.
	Kenyetta Tribble will also be using this program for articulation. The
	faculty committed \$100 to Staff Appreciation Day. They are trying to
	develop senate responsibilities through revising their constitution. They
	are looking at amending their constitution to include a vice president at
	the academic senate meetings. As it stands now, the constitution read
	the chair of the student services and the faculty development
	committees will act the vice presidents. We have not had a faculty
	development committee in several months and the student services chair
	does not attend academic senate meetings. The faculty looked at the
	mission statement and strategic initiatives up for the review at College
	Council.
	Derrasha reported they have a new senator and their health fair is
	schedule for Wednesday, April 28th. They had a successful coffee talk
	on the topic of a woman president even though student participation
	was minimal. The discussion was vibrant and worthwhile. Their Unity
	Day is scheduled for April 18th, 11:00 to 3:00 p.m. in the amphitheater.
	They will give prizes to the talent show participants, one being a \$100
	gas card. They will feature a spoken word artist and other performers in
	honor of African American history. All clubs will be represented on
	Unity Day. Currently they do not have anyone running for ASU
	president. This may cause a problem since next year our ASU president
	will be the governing board student trustee. The by-laws state that the
	ASU president must be a ASU senator first. The by-laws may have to
	be amended if we cannot find anyone to run for ASU president. Mack
	asked why the disinterest in running for such a prestigious position and
	Rasha responded, in her opinion, students don't want to take on that
	much responsibility and be accountable. The ASU will be gone April
	27-29 for the Community College conference. After some discussion, it
	was decided to change the Staff Appreciation Day to Friday, May 4,
	2007, in order to ensure student government attendance. Mack will
	send notice to Janis Walsh, Jason Berner and Laurie Laxa that the date

has been changed. The invitation on Staff Appreciation Day is also extended to student clubs.

Terence mentioned that he had spoken with Jennifer about a student leadership class. Mack said we had this at one time and it was taught by Ron Weston. Terence also mentioned that a student and classified rep are most welcome to attend the Academic Senate meetings and report on their constituency events. Matika is good about calling Terence to find out what she missed at the Academic Senate meetings but rarely reports on the student government events.

Mack reported that management is working on a shared governance statement for the College Handbook. We need a statement from the students to include as there is one for faculty and classified already. Terence said we need to evaluate how are shared governance processes are working. Terence also suggested a discussion board for college council so the e-mail discussions could be housed in one place on the email system. Mack will address that with James Eyestone. Mack continued the management report stating they will be working with Perkins and Will, the campus architects on Thursday, March 29th, 8:00 a.m. to 12:00 noon on the cost analysis of the seismic retrofits. They are working with the State law that says any remodel or repairs that exceed 50% of replacement costs will not be granted and a building should be removed and rebuilt. Mack said due to our space load capacity report, the Humanities Building will most likely be demolished once the Student Services Building is completed and the Math Department moves to the AA Building. The Humanities Building area may become the new student quad area. The final seismic report from the architect will be brought to College Council. Mack said we are also addressing at accessibility issues on campus. Mack said he will send out an e-mail to everyone notifying them of the trenching that will be done over spring break in front and in back of the SA Building as well as by the gym. The trenching will be conducted to give conclusive deniability or confirmation to a trace fault that may run through our campus. We are hoping most of the trenching will be completed during the spring break week but we are working with the food vendor for a temporary location for the food truck should the work continue after spring break.

3. FTES Goal for 2007-08	Mack reported the College FTES Goal for 2007-08 - Will remain the
	same 6,041 for next year. The district remains on stability this year so
	next year we have to make our FTES since our funding is dependent on
	what we receive from the State.

5. Student Fee Policy	Mack reported the implementation of Student Fee Policy is deferred to
	January 2008. We should be working on the policy now. Donna said
