Mack would like to encourage the group discussions to continue throughout the year. He reported that the managers are going to be discussing activities and ideas to improve teaching and learning. Mack said we need to engage in more campus conversations on classroom management or student resiliency or the like. There was some discussion about the new Faculty Handbook on line now and having it linked to the College Procedures Handbook. These are excellent resources for the faculty. |
| 4. Longwood Scholarship | Mack distributed a draft scholarship form and the criteria requested by Debra Longwood. Debra was the Foundation Manager before Linda Cherry and Mary Keating, many years ago. She had donated several thousands for a scholarship and now has given us the criteria she would like us to use in order to choose a student to be awarded \$300 (interest from the initial endowment) to be used toward college books. There was some discussion about the form and selection process. Some felt the criterion was too vague. Debra specifically asked President's Cabinet to be the committee to select the student.
