President's Cabinet Notes Friday, November 30, 2007 10:30 a.m., President's Conference Room

Mack explained that our ASU President, Tim Schulze is a concurrently enrolled student at Contra Costa College and attends Calvary Christian High School. He is not available until 2:30 p.m. and Mack would like to accommodate his schedule next semester. Mack asked everyone to check their calendars for next semester to see what day of the week would be good to meet at 2:30 p.m. the second and fourth weeks of the month.

Item	Outcome
1. Constituency Reports	Mack reported the managers had training on how to respond to
	the media. They included Laurie Laxa. The training was very
	helpful as it addressed some issues about our messaging. Our
	management group is trying to finish up our ideas on teaching
	and learning and how we may best use the \$50,000 generously
	donated by the Foundation. We are also establishing our
	classified recognition program. We agreed to honor a classified
	this spring at College Council. We have updated our telephone
	emergency list and are working on updating the building
	monitor list. We will using the \$400 donation from the Eagles
	Club to purchase emergency flashlights so we have enough for
	every building monitor. We discussed that certain managers
	should not be building monitors; depending on their role in an
	emergency, they will be needed elsewhere on campus.
	Mercy reported the Classified Senate discussed the building monitor list. They mentioned that Mike LeFebvre is retired and
	Ron Weston is listed as a monitor for the CTC when his office
	is located in the Liberal Arts Building. Also, there is only one
	building monitor for the Art and Music Building each. The
	Classified Senate suggested having a cell phone tree with the
	building monitor list. Mariles said the above noted changes the
	building monitor list have been given to Sgt. Chad Wehrmeister
	and they discussed a cell phone tree list in the debriefing
	meeting. Ultimately, Sgt. Wehrmeister would like to have three
	building monitors for each building and the building monitors
	will eventually train everyone in their building. Terence
	addressed the Cabinet by suggesting that faculty should be
	included in the talking to the media training. Mack said he
	agreed that we need to include faculty but ultimately
	management is responsible for everyone's safety on campus
	during an emergency and that is why we had the training first.

Mack said that Laurie Laxa or he should handle all media responses. In an emergency, management establishes a command center to provide the media with periodic updates and all information is localized to one spot. Currently Executive Staff is the team that reacts to an emergency.

Mercy continued her classified senate report and said there was discussion about the Shelter-in-Place order and further clarification needs to be given in the future as to lock the doors, etc. Mack responded by stating the information was changing constantly. Mack reminded everyone that as State employees we are all disaster workers. There was some discussion about the MCHS students. Mack said we will be getting our siren next semester. Mariles said they are also looking into getting the text message service along with the siren.

There was some discussion about *The Advocate* reporters and perhaps some sensitivity training for them. Mack said we need to let *The Advocate* know when we are dissatisfied with their reporting by writing letters to the editor. They are students and need feedback.

Mercy said the Classified are planning a spa day for their 2007-08 campus activity. There will be masseuses, candles and light music.

Terence announced the new senate president will be Richard Akers beginning July 1, 2008. They had an in-depth discussion about faculty completing their content review along with their program review and SLO's. The faculty senate does not have a campus spring event other than tagging on to the United Faculty to support Prop 92 campus event .

Mack said he has appreciated Terence's leadership on the academic senate and the many things he accomplished during his Presidency.

Mercy said she sent out an e-mail to the stewards of the Strategic Initiatives. It was decided at the last College Council meeting that each objective needs to have measurable outcomes.
