2. Strategic Initiatives -	Mack distributed the draft timeline for objectives to our Strategic
Stewards/Timeline	Initiatives. There was some discussion about the Stewards assigned to
	each initiative. It is important to have all constituency representation
	for each initiative. Terence suggested the SLO committee chaired by
	Donna (Kenyetta, Carol, Jim Duvall, Wendy Williams and Terence) to
	be the Steward for Strategic Initiative #1 along with Frank and division
	deans. We need to develop objectives this semester and prepare an
	annual report to be submitted to the governing board at the end of the
	academic year. Mack will designate managers for conveners of the
	Stewards but managers do not necessarily have to be chairs for any or
	all of the groups.
3. Training for Emergency	Mack announced he attend an emergency preparedness training hosted
Preparedness	by the State Chancellor's Office in collaboration with the State
	Homeland Security Department.
	Mariles reported our district police officer, Ted Terstegge, is our
	Emergency Preparedness officer and has been given a budget along
	with his new duties for training. The list of completed tasks by Officer
	Terstegge was distributed. Disaster supplies in rolling bins and a

	mobile command center (bus donated by LMC) have been established. The district has purchased a new siren system that is connected to the county warning siren. CCC will be the first campus to have the system installed. Mariles reported the first Safety Committee Meeting is on September 7th. The Crisis Management Committee will rename itself but Mariles does not know what the new name is at this time. She will report back once she finds out. That committee will address issues regarding students and/or employees who become "postal"; what signs to look for; and ultimately, what to do. Vicki Ferguson is the chair and it is comprised of our counselors Mack said Officer Terstegge and Mariles will address preparedness training at Division meetings where time may be allotted to address a question and answer period. Raja said the ASU will be offering a Student Life Event on September 11th where they will address mental health issues. Also on September 6th, Professor Manlove will be discussing earthquake preparedness from a scientist's point of view. The State will sponsor another training session in late September. A team from CCC will attend that training session
4. Status Report on Educational Master Plan	 session. Mack said we completed the Educational Master Plan last academic year and it was approved at College Council. Unfortunately the original cover was not printed in the duplication process and now we need to add the square footage report completed with the Facilities Plan. Therefore, the report will be reprinted with these corrections and further edits. Mack reported there is a State architecture meeting on September 17th where we hope to receive approximately 40 million dollars for our seismic retrofitting of some of our buildings. There is also some question about replacing the Liberal Arts Building at its current location; hence, the current trenching by the Humanities Building. The process has been arduous and frustrating as we are continually required to provide more information. We will be able to use 160 million of the Measure A 2006 bond monies for new buildings. If the State does not approve our plans to replace the Liberal Arts Building at its current location, we will have to make plans for another location on campus or make the new SA Building (already State approved), larger in square footage to accommodate our need for up-to-date classrooms.
5. Statement on Faculty, Classified and Students Roles in Shared Governance (College Procedures Handbook A1002.0)	Mack distributed the draft CCC College Handbook Procedure A1002 which lists the management statement approved at College Council last academic year. We have a district statement for classified, faculty and students in shared governance but now we need a campus statement. These statements will be drafted and brought to College Council on September 12th.
6. Enrollment - FTES	Carol said our enrollment grew this summer but currently is flat. DVC and LMC are above their goals at this time. Carol said we are looking at classes; talking to division deans and department chairs about how many sections we are offering of the same class. Math has gone up in enrollment and most of the classes offered in the LAVA Division have also gone up. The CLASS Division has declined slightly in enrollments as well as the P.E. Department. Mercy mentioned her off campus enrollments at the local high schools will be added after next week when the classes begin. There are several college students enrolled in

	those classes at the high schools. Terence asked about the talk of incentive pay for growing departments. Mack explained that district- wide if we grow we will be able to receive all of next year's COLA
	monies but if we do not grow district-wide, 1.25% or more will be deducted from next year's COLA monies.
7. Library and Learning	Carol said we have had nothing but delays due to the contractor that has
Resource Center	been working on the Library. We are now at the point of hiring our
	own contractors to finish the job. The HVAC and electrical systems as
	well as the fire alarm are not operational. A contractor has also been
	hired to finish the brick wall. We are now expecting the Library and
	Learning Resource Center to be open after Labor Day. We are now in
	cost overrun due to the extra contractors we have had to hire.
8. Faculty, Staff, Students &	Mack would like to see us work on event planning for this academic
Management Events 2007-	year with special events hosted by each constituency group. He asked
2008	each group to bring their events to the next President's Cabinet meeting.
9. 60th Anniversary of the	Mack distributed the district's timeline of the anniversary. The district
District	is planning a district-wide celebration and we should really do
	something for our campus. Our 60th anniversary date is October 10,
	2009. We will put together a committee for these activities. The
	nominations for this committee will be presented at the next President's
	Cabinet meeting. Raja said the students have wanted to do a fair for a
	while and this may be the perfect opportune time.
10. Other	Reports: Mercy reported the classified had a summer forum and they
	also attended the classified retreat at Lake Tahoe during the summer
	where many of classified were able to bond with classified from DVC
	and LMC as well as other colleges. The classified are looking to hold
	more forums. The next one is scheduled on October 3rd from 1:00 to
	2:00 p.m. They are also planning their annual winter retreat in
	December. Elections will be held on April 30th.
	Raja reported they had their first meeting yesterday. They talked about
	their upcoming event on September 11th where they will address
	mental health issues. Constitution Day is September 18th where they
	will invite Mayor Gayle McLaughlin, from the City of Richmond,
	Rocco Chavez and James Duvall to sit on a panel. The topic will be:
	"Why do more Americans vote for American Idol than they do for an
	American President?" They are making progress with the governing
	board student trustee coming from the DVC campus.
	Mack reported at the management retreat this summer, the managers
	decided to improve relations with the classified this year. Management
	will develop different ideas for making this happen this year.
	Terence did not have a report but did ask when the Dean for the CLASS
	Division job will be published. Carol said it should be out this semester
	for the person to begin in the Spring semester.
