Current SLO flow chart to be split into separate assessment groups: Course, Program, Institution, Mapping.

### Changes & Problems:

New single-purpose modules will be created to ONLY map Course SLOs to ILOs, individual Course SLOs to Program SLOs, and Program SLOs to ILOs. These modules will only need approval of Department Chairs and the SLO/AUO Coordinator.

A new CurricUNET SLO/AUO Assessment Manual will be created along with tutorials, videos, and hands-on professional development.
